## Introduction to Indooroopilly State High Alumni Consent Form for Indooroopilly State High School

Indooroopilly State High would like to keep contact with graduate students (referred to as "Alumni") and use an electronic details collection system to enable this process.

This letter is to inform you about the intention to offer this to graduating students and describe how your student's information, including personal information, may be recorded, used, disclosed, and published (if you provide your consent for this to occur).

The Indooroopilly State High Alumni Consent Form is a record of the consent provided for any student under the age of 18 to join the Indooroopilly State High Alumni by completing the online form. Students 18 or over do not need to complete this consent form and are able to join the Indooroopilly State High Alumni online by completing this online form.

# About the Indooroopilly State High Alumni Contact System

The Indooroopilly State High Alumni connects Indooroopilly State High's Alumni to one another and to Indooroopilly State High's current learning community. As a member of the Indooroopilly State High Alumni, Alumni will receive email updates, news and invitations for communal involvement. Details are sent to the Indooroopilly State High Communications Manager's email address and personal information is stored locally in the school network.

#### Student information

The consent collected by the form covers student permission to submit both student personal information (e.g. name, personal contact information) and school-based information (e.g., year level) on the Indooroopilly State High Alumni as outlined on the form.

## Purpose of the consent

The Indooroopilly State High Alumni Consent Form records your consent for your student to register via the Indooroopilly State School Website and for the specified personal information to be collected.

# Voluntary consent provision

It is not compulsory to provide consent. If your consent is not given, your student must wait until turning 18 years of age to opt in to join the Indooroopilly State High Alumni.

# Consent may be limited or withdrawn

You can withdraw your consent at any time by notifying the school in writing (by email or letter). The school will confirm the receipt of your request via email if you provide an email address.

#### **Duration of consent**

The consent applies for the period of time specified on the form. You may review and update your consent at any time by notifying the school in writing (by email or letter).
